Student Learning Outcomes

- Students will practice cultural relativism as it applies to the people of the countries in the Mediterranean region.
- Students will learn how to critically analyze and interpret cultural data from cultures found within the Mediterranean region.
- Students will apply anthropological principles for solving human problems on the local, regional and world scales.

Description

This course is part of a series to explore the diverse cultural heritage of the world using an anthropological perspective. In this case students cover the Mediterranean starting with the archaeological and historical past. Using anthropological methodology students explore the diversity within each culture, and then analyze the relationships within a worldwide context. As well, students are expected to synthesize the dynamics of power relationships within the culture in ancient and modern contexts by evaluating politics, economics, religion, and social development in the culture area. The course is designed to work with students either on an international program or intending to participate in a program of study in the Mediterranean.

- 6. Evaluate politics, economics, religion, and social development in the culture area in the ancient and modern contexts.
