### **Student Learning Outcomes**

- Recognize normal and abnormal anatomical structures.
- List the differential diagnosis for each disease process as related to the exam.
- Perform ultrasound exams according to the Scope of Practice for sonographer's identified by the SDMS and according to recognized examination protocols.

### Description

This course builds on the clinical competencies of DMS 72A. Preceptorship to obtain technical expertise with emphasis on mastery of knowledge, skills, and abilities required to perform sonographic studies and procedures. Emphasis is on elementary level for abdominal and gynecological examinations as to delineate complete anatomic and functional information for interpretation. Intended for students in the Diagnostic Medical Sonography Program; enrollment is limited to students accepted in the program.

### **Course Objectives**

The student will be able to:

- 1. Competently perform all primary examinations and procedures in a timely manner requiring elementary sonographic applications, including translating and calculation of quantitative data
- Obtain accurate clinical history, physical findings, and laboratory data for all types of patient procedures and examinations
- Operate with supervision several different types of sonography equipment in conjunction with examination completion within acceptable time limits
- 4. Apply the use of onboard computer calculations and various key functions of the ultrasound system with accuracy
- 5. Demonstrate excellent communication skills with patients, physicians, staff, and the public
- 6. Reinforce standards of practice when working with cultural sensitive environments, including various age and gender populations
- 7. Comply with "standards of practice" through the use of excellent communication skills, including adhering to the Standards of

Profession Behavior, including but not exclusive to ethical behavior in a clinical practice

# **Course Content**

This course is a clinical preceptorship with the student assigned to a hospital or other qualified medical facility. It is designed as an integrative approach.

- 1. Perform at the elementary level the following and applications, to include knowledge of didactic information and principles of all examinations and procedures, with supervision, including:
  - a. Gynecology
    - i. Transabdominal application
    - ii. Endovaginal application
  - b. Obstetrics
    - i. Transabdominal application
    - ii. Endovaginal application
  - c. Abdominal examinations
    - i. Tranabdominal application
    - ii. Subcostal approach
    - iii. Intercostal application
  - d. Invasive applications
    - i. Appropriate application to setting up sterile trays and instruments
    - ii. Ascertain the correct patient information matches the patient and is entered appropriately in the computer system
    - iii. Acquire patient data, including medical history and laboratory data relevant to the invasive procedure
- Obtain accurate clinical information, including medical history, physical findings, and laboratory data, and apply to the acquisition of anatomy with consideration of physiology and pathophysiology for the following subjects:
  - a. Gynecology
  - b. Obstetrics
  - c. Abdominal applications
- 3. Perform the sonographic examination in a timely manner consistent with this level of training
  - a. Uncomplicated abdominal examinations within 45 minutes
  - b. Uncomplicated gynecological examinations within 40 minutes
  - c. Uncomplicated obstetrical examinations for the first trimester within 30 minutes
  - Uncomplicated obstetrical examinations for the second trimester within 50 minutes
  - e. Uncomplicated obstetrical examinations for the third trimester within 50 minutes
- 4. Identify the various computer onboard calculations
  - a. Input calculations accurately
  - b. Recognize and explain the types and purposes of the various onboard computer calculations per patient examination
  - c. Demonstrate the key functions and knobology of each ultrasound system
  - d. Explain the methods to improve the sonographic image using the appropriate key functions
  - e. Judge quality of images based on accepted criteria, image assessment
  - f. Apply measurements correctly

- g. Criticize, appraise, and validate excellent image quality from nondiagnostic images
- Demonstrate excellent verbal, nonverbal, listening, and written communication skills with patients, staff, physicians, and the public in a culturally sensitive manner
  - a. Demonstrate excellent communication skills with physicians
  - b. Demonstrate excellent communication skills with staff
  - c. Assume responsibility for patient examinations and presentation through action
  - d. Apply program and department policy and procedures
- 6. Recognize and apply "standards of practice" when working with cultural sensitive patient, physicians, staff, and the general public through the use of excellent communication skills
  - a. Oral skills
  - b. Written skills
  - c. Nonverbal skills
